# BOARD OF PUBLIC WORKS & SAFETY & STORMWATER BOARD MINUTES OF THE NOV. 22, 2021 REGULAR MEETING

Convened at 2 p.m. at Goshen Police & Court Building, 111 East Jefferson Street, Goshen, Indiana

**Present:** Mayor Jeremy Stutsman and members Mike Landis, Mary Nichols, and Barb Swartley **Absent:** DeWayne Riouse

Call to Order: Mayor Jeremy Stutsman called the meeting to order at 2 p.m.

Review/approval of Minutes: The minutes of the Nov. 15, 2021 meeting of the Board of Works & Safety & Stormwater Board were presented. Board member Mary Nichols moved to approve the minutes as presented and the motion was seconded by Board member Barb Swartley. Motion passed 4-0.

Review/approval of Agenda: Mayor Stutsman presented the Board agenda. Nichols moved to approve the agenda as submitted. Swartley seconded the motion. Motion passed 4-0.

1) Hiring and Swearing in of Megan J. Berry as Probationary Firefighter (Chief Sink) Fire Department Chief Dan Sink asked the Board to hire Megan J. Berry as a Probationary Firefighter for the Goshen Fire Department effective today, Nov. 22, 2021. Sink reported that Berry has passed all of pension requirements for the State of Indiana.

Nichols/Swartley moved to hire Megan J. Berry as a Probationary Firefighter for the Goshen Fire Department, effective Nov. 22, 2021. Motion passed 4-0. Mayor Stutsman then swore Berry into office.

2) Hiring and Swearing in of Hannah M. Estes as Probationary Firefighter (Chief Sink) Fire Department Chief Dan Sink asked the Board to hire Hannah M. Estes as a Probationary Firefighter for the Goshen Fire Department effective today, Nov. 22, 2021. Sink reported that Estes has passed all of pension requirements for the State of Indiana.

Nichols/Swartley moved to hire Hannah M. Estes as a Probationary Firefighter for the Goshen Fire Department, effective Nov. 22, 2021. Motion passed 4-0. Mayor Stutsman then swore Estes into office.

### 3) Electrical License Request for David E. Sloan of Indianapolis (Myron Grise)

**City Building Commissioner Myron Grise** asked the Board to approve a City of Goshen electrical license for David E, Sloan with Indy Voltage LLC of Indianapolis. Grise reported that Sloan has met the requirements for a City of Goshen Electrical License. Grise said Sloan took the required Prometric exam on July 15, 2000, and received a passing score of 82.5%. Grise said Sloan holds a valid electrical license with the City of Indianapolis, and is requesting a reciprocal license with the City of Goshen.

Nichols/Swartley moved to approve a City of Goshen electrical license for David E, Sloan with Indy Voltage LLC of Indianapolis. Motion passed 4-0.



### 4) Amendment to LPA-Consulting Contract with Abonmarche Consultants, Inc. (Carla Newcomer)

**Carla Newcomer**, a paralegal with the City Legal Department, asked the Board to approve and execute the Amendment to the LPA-Consulting Contract with Abonmarche Consultants, Inc. for preliminary engineering services for the reconstruction of Wilden Avenue from Rock Run Creek Bridge to 6th Street. Newcomer said the contract was originally executed Dec. 15, 2014 and amended June 1, 2020. This amendment adds asbestos inspection services of five structures to be demolished for an additional cost of \$3,100, and staking of right-of-way and the location of each curb inlet structure for an additional cost of \$4,800. This Amendment increases the compensation due under the contract to a total fee not to exceed \$337,900.

Nichols/Swartley moved to approve and execute the Amendment to the LPA-Consulting Contract with Abonmarche Consultants, Inc. for preliminary engineering services for the reconstruction of Wilden Avenue from Rock Run Creek Bridge to 6th Street. Motion passed 4-0.

### 5) Economic Development Corporation of Elkhart County Funds Agreement (Brandy Henderson)

**Brandy Henderson**, a paralegal with the City Legal Department, told the Board that the City of Goshen has various community service organizations that provide services or programs to its residents in a manner more efficient than what the City could provide. She said the City has supported these organizations with funds in the past and wishes to continue to do so. These organizations were subject to an application process requiring specific documentation regarding their organization, a detailed description of how these funds will be used, and the organizations will need to account for how the funds were used. Henderson said the Economic Development Corporation of Elkhart County is one such community service organization that has applied for these funds. It has requested \$65,219 for economic development and operations efficiency. Henderson said the Economic Development Corporation of Elkhart County has provided all the required information and an agreement is now being brought to the Board for consideration and approval.

Nichols/Swartley moved to approve the agreement with Center for Business Excellence, Inc. to support the project or projects outlined in its submitted application. Motion passed 4-0.

### 6) Amend Uniform Service Contract with Wildman Business Group, Inc. (Brandy Henderson)

**Brandy Henderson**, a **paralegal with the City Legal Department**, asked the Board to approve an agreement amendment with Wildman Business Group, Inc. and authorize Mayor Stutsman to execute it. She said the City entered into a contract with Wildman Business Group, Inc., dated Sept. 11, 2017, to provide a Uniform Service for City employees for the unit cost amounts in accordance with the supplier's itemized quote and based on the quantities required by the City. The contract allows for two additional two-year terms under the same terms and conditions. The City desires to renew the term of the contract for the third two-year term from Jan. 1, 2022 through Dec. 31, 2023. The City has asked, and Wildman has agreed, to add to the scope of services under this amended agreement uniforms for the Parks and Recreation Department's 6-pesron team. Also added to the scope of services is entryway mat services to the Annex Building, City Hall, Police and Courts Building, and the Utilities Building. This service will begin Nov. 30, 2021. All other terms and conditions of the Sept. 11, 2017 contract remain the same. **Nichols/Swartley moved to approve the attached agreement amendment with Wildman Business Group, Inc.** and authorize Mayor Stutsman to execute the same. **Motion passed 4-0**.



### 7) Agreement with Eaton Corporation (Brandy Henderson)

**Brandy Henderson**, a **paralegal with the City Legal Department**, asked the Board to approve and authorize Mayor Stutsman to execute the agreement with Eaton Corporation for the evaluation of five (5) breakers for the purpose of reconditioning with the total cost being \$5,600 and said costs to be applied to any expenses for reconditioning in the future. She said should the evaluation determine that the breakers can be reconditioned, the Waste Water Treatment Plant intends on keeping these breakers as emergency replacements should the need ever arise. Henderson said Eaton will be paid \$1,120 per breaker with a total sum of \$5,600 and this expense will be applied to the reconditioning expenses should the City proceed in that direction.

Nichols/Swartley moved to approve and authorize Mayor Stutsman to execute the agreement with Eaton Corporation for the evaluation of five (5) breakers for the purpose of reconditioning with the total cost being \$5,600 and said costs to be applied to any expenses for reconditioning in the future. Motion passed 4-0.

### 8) Agreement with Design Group International (Brandy Henderson)

**Brandy Henderson**, a **paralegal with the City Legal Department**, asked the Board to approve and authorize the Mayor to execute the agreement with Design Group International for consulting services on organizational, visional, and workload management planning for the Department of Environmental Resilience Henderson said Design Group International will be paid \$8,750 for these for the services.

Nichols/Swartley moved to approve and authorize the Mayor to execute the agreement with Design Group International for consulting services on organizational, visional, and workload management planning for the Department of Environmental Resilience at a cost of \$8,750. Motion passed 4-0.

### 9) Agreement with Aquascapes of Michiana, LLC (Carla Newcomer)

**Carla Newcomer**, a **paralegal with the City Legal Department**, asked the Board to approve and execute the agreement with Aquascapes of Michiana, LLC for snow removal within the Goshen Downtown Economic Improvement District. Aquascapes will be paid at an hourly rate of \$85 per hour for the removal of snow within the downtown Economic Improvement District. In response to a question from **Mayor Stutsman** about the higher rate than in the past, **City Attorney Bodie Stegelmann** confirmed the company will be using its own equipment this winter. The **Mayor** said now pushed to the curbs will be removed by City crews.

Nichols/Swartley moved to approve and execute the agreement with Aquascapes of Michiana, LLC for snow removal in the Goshen Downtown Economic Improvement District. Motion passed 4-0.

### 10) Agreement with Mechanical Man, Inc. (Carla Newcomer)

**Carla Newcomer**, a paralegal with the City Legal Department, asked the Board to approve and execute the agreement with Mechanical Man, Inc. for the demineralization of the boiler water at the Police Department. Mechanical Man will be paid \$9,983 to demineralize water in boiler system to the manufacturer's water quality specification, install a 55-gallon feeder reservoir; disconnect the boiler system from the City water feed; bleed the boiler system, as necessary; and provide a disposable demineralizer.

Nichols/Swartley moved to approve and execute the agreement with Mechanical Man, Inc. for the demineralization of the boiler water at the Police Department in the amount of \$9,983. Motion passed 4-0.



### 11) Agreement with OJS Building Services, Inc. (Carla Newcomer)

**Carla Newcomer**, a paralegal with the City Legal Department, asked the Board to approve and execute the agreement with OJS Building Services, Inc. to provide and install hot water valves at the Goshen Police Department for \$27,750. Newcomer said attached to the agreement was an amendment to the Aug. 28, 2018 agreement with OJS Building Services, Inc. for the replacement of hot water valves at the Police Department. OJS Building Services, Inc. will install 40 Belimo modulating valves, piping materials, and provide testing. **City Director of Public Works and Utilities Dustin Sailor** provided further information on the purpose of the work.

Nichols/Swartley moved to approve and execute the agreement with OJS Building Services, Inc. to provide and install hot water valves at the Goshen City Police Department for \$27,750. Motion passed 4-0.

# 12) Agreement for the Completion of the Construction Project 1211 Camelot Drive (JN: 2017-2045) (Mattie Lehman)

**City Stormwater Specialist** asked the Board to approve the agreement for the completion of the construction project at 1211 Camelot Drive with Kadd Acquisitions LLC. She said builder Schrock Homes has passed its final building inspection for 1211 Camelot Drive and the project is substantially complete except for seeding disturbed areas. This final Stormwater Department requirement cannot be completed at this time due to weather conditions. So, the Stormwater Department has submitted an Agreement for the Completion of the Construction Project for approval and authorization for the Mayor to execute. The property owner, Kadd Acquisitions LLC (land holding company related to Schrock Homes), has agreed to permanently stabilize 7,000 square feet of disturbed area with seed and a temporary stabilization measure by June 15, 2022. The expected cost of work is less than \$2,000; thus, no surety amount is required. This is the first such agreement under the new Board of Works and Public Safety Resolution 2021-29 "A Policy for the Issuance of Certificate of Occupancy Prior to Completion of Construction Project." More agreements of this kind are expected in the coming months.

Nichols/Swartley moved to approve the agreement for the completion of the construction project at 1211 Camelot Drive with Kadd Acquisitions LLC. Motion passed 4-0.

# 13) Post-Construction Plan Approval Keystone RV Building Additions and Parking Expansion (JN: 2021-2010 and 2021-2032) (Jason Kauffman)

**City Stormwater Coordinator Jason Kauffman** asked the Board accept the post-construction stormwater management plan for Keystone RV Building Additions and Parking Expansion as it has been found to meet the requirements of City Ordinance 4329.



Kauffman said the developer of the Keystone RV Parking Lot Expansion, located at 2442 East Kercher Road, and Keystone RV Additions, located at 2525 Linden Drive affecting one or more acres of land, has submitted a sufficient post-construction plan that is compliant with Ordinance 4329, "Uniform Requirements for Post-Construction Stormwater Management."

Nichols/Landis moved to accept the post-construction stormwater management plan for Keystone RV Building Additions and Parking Expansion as it has been found to meet the requirements of City Ordinance 4329. Motion passed 3-0.

### 15) WWTP Improvements Project – Change Order No. 4 (JN: 2019-0025A) (Bryce Gast)

Administrative City Engineer Bryce Gast asked the Board to approve Change Order No. 4 for a cost reduction of \$172,286, with no change to the project schedule, for the Wastewater Treatment Plant Improvement Project. A change order prepared by Donohue and Associates includes a total of seven changes to the project: five are additional costs and two are cost reductions. HE said the changes include the following: addition of a sidewalk to the vactor truck receiving facility to improve access for an additional cost of \$9,917; modification of the new digester gas piping to improve moisture control in the process for an additional cost of \$3,172; addition of a pipe fitting to the aeration process piping after the original was deemed to be unsuitable for reuse for an additional cost of \$930; replacement of diffuser o-rings in the aeration tanks for an additional cost of \$2,382; modification of the diffuser grid in the existing aeration tanks to better match the diffuser grid in the new aeration tank for an additional cost of \$3,086; removal of the sludge lagoon decommissioning from the project scope for a cost reduction of \$178,256.00 (Note: This cost is removed from the project scope but will still be incurred by the Wastewater Utility); removal of a substantial portion of painting scope from the secondary clarifiers and upflow clarifiers for a cost reduction of \$13,517. The change order is for a cost decrease of \$172,286, which reduces the total project cost to \$18,970,526. This change order is a decrease of 0.9% and lowers the project cost below the original bid cost by 0.1%. The change order adds no time to the project schedule, though Kokosing has reserved the right to request additional time at a later date. Asked by Mayor Stutsman if the price included the cost to haul away sludge from the lagoon, Gast said it did not. Gast said the city will have to pay that as well as costs to decommission the lagoon. Mayor Stutsman said any further time extensions of additional costs not requested by the City will need to be requested by Kokosing. In response to a question by Board member Landis, Gast said another company will decommission the lagoon. Nichols/Swartley moved to approve Change Order No. 4, for a cost reduction of \$172,286, with no change to the project schedule, for the Wastewater Treatment Plant Improvement Project. Motion passed 4-0.



Privilege of the Floor:

Mayor Stutsman opened Privilege of the Floor at 2:28 p.m. No one asked to speak, so the Mayor closed Privilege of the Floor.

**Clerk-Treasurer Aguirre** advised **Mayor Stutsman** that there was a discrepancy on agenda item #5 in the intended name of the entity and the entity mentioned in actual Board motion. The agreement is/was between the City of Goshen and the Economic Development Corporation of Elkhart County. However, the Board's motion stated that the agreement was between the City of Goshen and the Center for Business Excellence, Inc. **Brandy Henderson**, a paralegal with the City Legal Department, who presented the item to the Board, stated that the suggested motion in her packet memo was incorrect. She stated that entity involved is/was the Economic Development Corporation of Elkhart County and that the actual agreement is correct. In repose to a question from Mayor Stutsman, Board members said they were not confused in approving the agreement. They knew it was the Economic Development Corporation of Elkhart County.

With no further matters before the Board, Mayor Stutsman/Nichols moved to approve Civil City and Utility claims and to adjourn the meeting. Motion passed 4-0. Meeting was adjourned at 2:30 p.m.

### AGREEMENT AMENDMENT

### **Purchase of Chemicals**

THIS AGREEMENT AMENDMENT is entered into on \_\_\_\_\_\_, 2021, by and between **Alexander Chemical Corporation** ("Alexander"), whose mailing address is 315 5<sup>th</sup> Street, PO Box 599, Peru, IL 61354, and **City of Goshen, Indiana**, a municipal corporation and political subdivision of the State of Indiana acting through the Goshen Board of Public Works and Safety ("City").

### RECITALS

- (1) City and Alexander entered into an Agreement on December 26, 2018 for the City's purchase and Alexander's supply of chlorine, hydrofluosilicic acid, and mercury free/reduced sodium hypochlorite.
- (2) Upon written approval of both parties, the Agreement may be renewed for three additional one-year terms under the same terms and conditions.
- (3) The parties wish to renew the Agreement for the third and final one-year term.

In consideration of the terms, covenants and conditions to be kept and performed under the original Agreement dated December 26, 2018, and under the terms, covenants and conditions of this amendment, the parties agree as follows:

### TERM

The term of the Agreement for the City's purchase and Alexander's supply of chlorine, hydrofluosilicic acid, and mercury free/reduced sodium hypochlorite shall be extended through December 31, 2022.

### **ORIGINAL AGREEMENT**

In all respects, all other provisions of the original Agreement dated December 26, 2018 shall remain in full force and effect.

### **AUTHORITY TO EXECUTE**

The undersigned affirm that all steps have been taken to authorize execution of this Agreement Amendment, and upon the undersigned's execution, bind their respective organizations to the terms of the Agreement Amendment.

Attached is an Agreement Amendment with L&M Electric for the Electrical Maintenance of Traffic Signals, School Flashers, Lighting, City Buildings and the Airport. The Amendment extends the Agreement from January 1, 2022, through December 31, 2022, under the same terms and conditions as the February 15, 2021, contract.

### AMENDMENT NO. 1

### ELECTRIC MAINTENANCE SERVICE FOR THE CITY'S TRAFFIC SIGNALS, SCHOOL FLASHERS, LIGHTING, CITY BUILDINGS AND AIRPORT

Habitat for Humanity has passed their final building inspection for 123 N 6<sup>th</sup> St and the project is substantially complete except for seeding disturbed areas, planting of a street tree, and possible repairs to damaged sidewalk. These final requirements cannot be completed at this time due to weather conditions.

The Stormwater Department thus submits an Agreement for the Completion of the Construction Project for approval and authorization for the Mayor to execute.

Under the Agreement, the property owner, Habitat for Humanity of Elkhart County, Inc. agrees to permanently stabilize 5,000 square feet of disturbed area with seed and a temporary stabilization measure, plant the required street tree, and repair any damage to sidewalk by June 15, 2022.

The expected cost of remaining work is \$1,550 and a surety for that amount has been submitted to the Clerk Treasurer's office. A surety is required because of the included concrete work.

Permittee is not required to provide Goshen a surety to guarantee the timely and proper completion of the Work.

- 3. CERTIFICATE OF OCCUPANCY. Except for the Work yet to be completed as set forth in Section 1 above, once the construction project complies with all applicable City ordinances and requirements, Goshen will issue a Certificate of Occupancy for the Site on the condition that Permittee complies with the terms of this agreement. It is Permittee's obligation to contact the Goshen Building Department to obtain the Certificate of Occupancy prior to occupying the building.
- 4. FORCE MAJEURE. If Permittee's performance under this agreement is prevented because of an occurrence that is beyond the control of the Permittee which could not have been avoided by exercising reasonable diligence, Permittee's time for performance will be extended. Such extension shall be for no longer than necessary given the nature of the occurrence which causes the delay. Examples of such occurrences are tornadoes, floods, or more than a typical number of days where rainfall prohibits the performance required of the Permittee.

If Permittee is delayed, Permittee shall immediately notify Goshen in writing describing the nature of the event delaying performance. Permittee shall make every effort to resume performance as soon as possible.

5. **DEFAULT.** It is mutually agreed that if Permittee fails to perform or comply with the terms of this agreement, Goshen may declare the agreement to be in default without notice to Permittee.

Upon declaration of default, Goshen may take such action as is necessary to complete Permittee's obligations although Goshen is not obligated to do so. If Surety is provided under this agreement, Goshen may use the Surety to pay for the completion of any of Permittee's obligations. Goshen may seek any other remedy available at law or equity in addition to or instead of any remedy provided for in this agreement.

Goshen shall have the right to correct any defect in the Work, and Goshen shall have the right to stabilize the Site in accordance with the Goshen City Construction Site Stormwater Runoff Control Ordinance. The Surety, if required, and/or Permittee shall pay all of Goshen's costs and expenses incurred in taking such actions including, but not limited to engineering, legal and other costs, together with any damages either direct or consequential which Goshen may sustain on account of Permittee's failure to fulfill Permittee's obligations under this agreement.

- 6. **SUBCONTRACTING OR ASSIGNMENT OF CONTRACT.** Permittee shall not subcontract or assign any right or interest under the agreement without having prior written approval from the Goshen Board of Public Works and Safety, provided, however, that Permittee shall be permitted to independently engage any contractors, subcontractors, or laborers to perform the Work, and such engagement shall not be considered to be an impermissible subcontracting or assignment by Permittee of any right or interest under this agreement. Except as provided herein, any attempt by Permittee to subcontract or assign any portion of the agreement shall not be construed to relieve Permittee from any responsibility to fulfill Permittee's obligations.
- 7. **AMENDMENTS.** Any modification or amendment to the terms and conditions of the agreement shall not be binding unless made in writing and signed by both parties and such modification is approved by the Goshen Board of Public Works and Safety. Any verbal representations or modifications concerning the agreement shall be of no force and effect.

- 8. WAIVER OF RIGHTS. No right conferred on either party under this agreement shall be deemed waived and no breach of this agreement excused unless such waiver or excuse shall be in writing and signed by the party claimed to have waived such right.
- 9. NOTICES. All written notices, properly addressed and sent by U.S. mail or delivered personally to the address provided below shall constitute sufficient notice whenever written notice is required for any purpose in this agreement. ### Definitions

- 1. Transverse Crack Cracks perpendicular to the pavement's centerline.
- 2. Longitudinal Crack Cracks parallel to the pavement's centerline.
- 3. Rutting Surface depression in the wheel path of the pavement.
- 4. Block Cracking Interconnected cracks that divide the pavement up into rectangular pieces.
- 5. Alligator Cracking A series of interconnected cracks caused by fatigue failure of the HMA surface under repeated traffic loading.
- **6. Raveling** The progressive disintegration of an HMA layer from the surface downward as a result of the dislodgement of aggregate particles.

### **Report Overview**

The purpose of this inspection report was to rate the current pavement conditions of each street segment and to identify needed maintenance and repair of the 137 roadway miles under the jurisdiction of the City of Goshen utilizing the PASER guidelines. The results of the study will be the basis for the development of programs depending on availability of funds. The study should be kept current on an annual basis.

### **Goals and Objectives**

It is the City of Goshen's goal to use the inventory and condition ratings to apply appropriate roadway preservation techniques in order to extend the life of the City's roadways in a cost effective manner. It is the City's goal to reduce the number of poor roads (PASER rating 1-4) from 70% to 30% in the next 20 years.

### What is the PASER System?

The Pavement Surface Evaluation and Rating (PASER) system visually evaluates the condition of road segments. Ratings are applied to road segments of varying length, with segment values ranging from 10 for a new road segment to 1 for a completely failed segment, and specific ratings determined by the number and type of surface defects. The rating is based upon the worst area within the street segment.

PASER also recommends needed maintenance or repair, based on the condition of the roadway. PASER Ratings for this report are divided into the following maintenance categories:

 Roads with PASER ratings of 8-10 (Good Condition) require Routine Maintenance. Routine maintenance encompasses day-to-day maintenance activities, such as street sweeping, drainage, shoulder gravel grading, and sealing cracks to prevent standing water and water penetration.



There are no visible distresses in PASER ratings 9 and 10 because they are new constructions or recent overlays.

Pictured is River Race Drive between Madison Street and Monroe Street shows no signs of wear.



Roadways with a PASER rating 8 have no longitudinal cracks, except for reflection of pavement joints. Occasional transverse cracks spaced 40 feet or more apart. All cracks are sealed or tight (open less than 1/4").

Pictured is Martin Avenue from the Meijer Access Road to Corporate limits. This roadway has small occasional cracks, and requires very little maintenance.

Roads with PASER ratings of 5-7 (Fair Condition) require Capital Preventative Maintenance. Capital preventative maintenance is a planned set of cost-effective treatments to an existing roadway system that slow down future deterioration and maintain or improve the functional condition of the system without significantly increasing structural capacity. The purpose of capital preventative maintenance fixes is to protect the pavement structure, slow the rate of pavement deterioration, and/or correct pavement surface deficiencies. These treatments are targeted at pavement surface defects primarily caused by the environment and by pavement material deficiencies.



PASER rating 7 pavement can include very slight or no raveling and shows surface some wear. Longitudinal cracks from reflection or paving joints can be up to 1/4" wide and transverse cracks can be up to 1/4" wide and spaced between 10' and 40' apart. There is little or slight crack raveling, no patching, or very few patches in excellant condition.

Pictured is Wheatland Drive from Barley Lane to Oatfield Lane. This roadway has some longitudinal cracks. There are also transverse cracks 10'-40' apart. Most of the cracks are not open due to being crack sealed in 2015.



Roadways with a PASER rating of 6 are starting to show signs of traffic wear and/or raveling. There are open longitudinal cracks with a width between 1/4"-1/2". Transverse cracks are open with a width between 1/4"-1/2" with some being less than 10' apart. The first signs of block cracking can appear, slight to moderate flushing or polishing, and it may have occasional patches in good condition.

Pictured is Waterford Mills Parkway between Regent Street and Edison Drive. This roadway has transverse cracks that are open between  $\frac{1}{2}$  and  $\frac{1}{2}$  and are less than 10 feet apart. Some longitudinal cracking along the corridor.



Roadways with a PASER rating of 5 have moderate to severe raveling, longitudinal and transverse cracks open 1/2" or more and secondary cracks. Block cracking on up to 50% of the pavement surface, extensive to severe polishing, and some patching or wedging in good condition.

PASER Rating 5

Pictured is Mountain Ash Lane between Redspire Boulevard and Tulip Boulevard. This roadway has transverse cracks that are greater than 1/2" wide.

#### Roads with PASER ratings of 1-4 (Poor Condition) require Structural Improvements.

This category includes work identified as rehabilitation and reconstruction, addressing the structural integrity of a road.



PASER rating 4 roadways have severe surface raveling, multiple longitudinal and transverse cracks with slight raveling, block cracking over 50% of the surface, patching in fair condition, and rutting of less than 1/2".

PASER Rating 4

Pictured is Sixth Street between Lincoln Avenue and Washington Street. This roadway has longitudinal cracks in the wheel path and the block cracking.



Roadways with PASER rating 3 may have closely spaced longitudinal and transverse cracks, severe block cracking, alligator cracking on less than 25% of the surface, patches in fair to poor condition, occasional potholes, and rutting between 1/2" and 2".

Pictured is Lincoln Avenue between Greene Road and Silverwood Lane. This roadway has longitudinal and transverse cracks that are showing erosion, and there is also rutting in the wheel path.



A PASER rating 2 road has cracking over 25% of the surface, rutting greater than 2", patches in poor condition, and potholes.

Pictured is VanGuilst Drive between Alfalfa Street and Michigan Street. This roadway has alligator cracking over 25% of the surface, and patches that are in poor condition.



PASER rating 1 roadways have severe distress with a loss of surface integrity.

Pictured is Westfield Drive between Pike Street and Wilkinson Street. This roadway has extensive alligator cracking and multiple patches that are in poor condition making it a PASER rating 1.

### **Study Methodology**

The City of Goshen utilized 2-person data collection teams. Each roadway segment was driven. At the end of the segment, the team discussed the roadway and documented on a data collection sheet the factors that resulted in the segment rating. All segments were entered into a spreadsheet that will allow for easy data presentation. Data for the 2020 report was collected between March 9, 2020 and March 16, 2020.


Team members of the data collection attended a training session that took place in Shipshewana hosted by Indiana Local Technical Assistance Program (LTAP) on March 28, 2018. Participants received an overview of the project and were given instructions on how to use the PASER road rating system for data collection.

#### **Goshen's Existing Roadway Conditions**

A detailed table of the system is included in Appendix A. The table below provides a summary of the mileage and condition rating for the City. A rating of 5 is the minimum acceptable pavement condition, because it is the last rating that does not require structural repairs. Currently the average rating per lane mile for the City's network is **4.49**.

#### How to use the PASER Data?

The 2020 PASER data is in spreadsheet form. The City can easily sort this data in a variety of ways. Possible data sorting scenarios include the following:

- All data sorted by PASER rating (high to low).
- Road classification sorted by PASER rating.

#### Pavement Maintenance and Cost Considerations

A good pavement maintenance program involves a combination of activities that revolve around the principal that once pavement gets to a certain condition, that the deterioration of the pavement accelerates. Maintenance items such as crack sealing on roads with PASER ratings in the Good categories (PASER Ratings 8-10) and sealing or micro-surfacing roadways with PASER ratings in the Fair categories (PASER Rating 5-7) are an essential part of roadway maintenance program. Crack sealing is a low-cost method to keep the roads from needing high cost reconstruction. Structural improvements are recommended for streets with a PASER Rating of 4 or below. Streets with a PASER Rating 3-4 are typically slated for milling and overlay with full depth patches. Street with a PASER Rating 1-2 are typically full-depth pavement reconstruction projects. The following table summarizes the anticipated costs associated with the City of Goshen's streets.

The above methods are the most used methods for the City of Goshen. The costs alone show why it is so important maintain the higher rated streets and keep them from failure. The crack sealing and chip sealing is typically done with in-house crews, whereas the other options are bid and done by a contractor.


## **Recommendations and Conclusions**


This report provides the City with valuable information to assist in determining the annual maintenance budget. The results of this plan provide the City with a summary of the potential costs and different life cycle options that can be used in creating a plan for road maintenance. However, if more manhours were available, much more could be done to better track the deterioration and current condition of the pavement and the associated costs of maintenance. With the improved data, analysis and optimization, there would be a potential for a significant increase in the amount of improvement realized per dollar spent.

While many of the City's streets are not in need of complete reconstruction, the overall network is currently deteriorating year over year. There are several options that are currently used and some that are being considered to help preserve and extend the life of City streets. It is important to utilize preventative maintenance treatments early on in the life cycle of pavement, while the pavement is in good condition in order to extend the life of the pavement. Biennial monitoring of all streets will need to be done to ensure that roadways are deteriorating at expected rates. This will help to find what maintenance methods help extend the lifecycle of the pavement most efficiently. Drainage conditions need to be looked at as well to determine if a drainage issue is causing the pavement failure. With overlays and reconstructions, the drainage catch basins may need to be adjusted to make sure that water is not trapped on the pavement. The following is a list of recommendations presented in this report:

- Adopt this plan as a framework for future maintenance and rehabilitation of the City of Goshen's Streets.
- The City should perform routine maintenance on streets with condition ratings of 7 and higher to extend the life of those streets.
- The City should also perform routine maintenance on streets with condition ratings of 5-6 but may also need to look at performing some structural repairs and patchwork or overlays.
- The City should perform patching or mill and overlays for ratings of 3-4.
- The City should perform full reconstruction on streets will a rating of 1-2.
- The City should consider investment in a comprehensive asset management program to better optimize each dollar spent.

#### AGREEMENT

#### SURVEYING SERVICES FOR MULTIPLE SITES

THIS AGREEMENT is entered into on \_\_\_\_\_\_, 2021, which is the last signature date set forth below, by and between **Jones Petrie Rafinski**, **Corp.** ("Contractor"), whose mailing address is 325 South Lafayette Blvd., South Bend, IN 46601, and **City of Goshen, Indiana**, a municipal corporation and political subdivision of the State of Indiana acting through the Goshen Board of Public Works and Safety ("City").

In consideration of the terms, conditions and mutual covenants contained in this agreement, the parties agree as follows:

#### Section 1. Contractor Duties

Contractor shall provide City the following services which shall include the provision of all labor, supplies, materials, tools, equipment, supervision, insurance and all other items necessary to survey multiple sites within the City of Goshen (hereinafter referred to as "Duties"). Contractor's Duties under this agreement include:

- (A) Fire Training facility boundary and topographic survey
- (B) Hickory Street topographic survey
- (C) 1012 Hickory Street topographic survey
- (D) Alley 250 (Theater Alley) topographic survey
- (E) Clinton Street Between Main Street and 5<sup>th</sup> Street topographic survey
- (F) Berkey Avenue between Dewey Avenue and Indiana Avenue topographic survey

Contractor shall provide City the services for the Surveying Services for Multiple Sites, which services are more particularly described in Contractor's November 10, 2021 proposal attached as Exhibit A (hereinafter referred to as "Duties").

In the event of any conflict between the terms of this agreement and the terms contained in the proposal attached as Exhibit A, the terms set forth in this agreement shall prevail.

#### Section 2. Effective Date; Term

- (A) The agreement shall become effective on the day of execution and approval by both parties.
- (B) Contractor acknowledges that time is of the essence and that the timely performance of its Duties is an important element of this agreement. Contractor shall perform all Duties as expeditiously as is consistent with professional skill and care in the orderly progress of the Duties.
- (C) Contractor shall complete all Duties within five (5) weeks of the date of the notice to proceed.

#### Section 3. Compensation

- (A) City agrees to compensate Contractor the sum of \$28,000.00 for performing all Duties.
- (B) City agrees to compensate Contractor as follows for performing all Duties:

#### Section 4. Payment

- (A) City shall pay Contractor for each phase of Duties satisfactorily completed under this agreement as Duties progress.
- (B) Payment shall be upon City's receipt of a detailed invoice from Contractor. The invoice shall be sent to the following address, or at such other address as City may designate in writing.

City of Goshen c/o Goshen Engineering Department 204 East Jefferson Street, Suite 1 Goshen, IN 46528

- (C) Payment will be made within forty-five (45) days following City's receipt of the invoice. If any dispute arises, the undisputed amount will be paid. Payment is deemed to be made on the date of mailing the check.
- (D) Contractor is required to have a current W-9 form on file with the Goshen Clerk-Treasurer's Office before City will issue payment.

#### Section 5. Ownership of Documents

All documents, records, applications, plans, drawings, specifications, reports, and other materials, regardless of the medium in which they are fixed, (collectively "Documents") prepared by Contractor or Contractor's employees, agents or subcontractors under this agreement, shall become and remain the property of and may be used by City. Contractor may retain a copy of the Documents for its records.

#### Section 6. Licensing/Certification Standards

Contractor certifies that Contractor possesses and agrees to maintain any and all licenses, certifications, or accreditations as required for the services provided by Contractor pursuant to this agreement.

#### Section 7. Inspection

All products, materials, components, equipment, supplies or workmanship entering into the performance of this contract shall be as specified in the Specification Documents, free of defects, and subject to the City's inspection and testing. The City shall have the right to reject and return at Contractor's expense or to require at Contractor's expense, the correction or replacement of products, materials, components, equipment, supplies or workmanship which are defective or do not conform to the requirements of the Specification Documents.

#### Section 8. Independent Contractor

- (A) Contractor shall operate as a separate entity and independent contractor of the City of Goshen. Any employees, agents or subcontractors of Contractor shall be under the sole and exclusive direction and control of Contractor and shall not be considered employees, agents or subcontractors of City. City shall not be responsible for injury, including death, to any persons or damages to any property arising out of the acts or omissions of Contractor and/or Contractor's employees, agents or subcontractors.
- (B) Contractor understands that City will not carry worker's compensation or any other insurance on Contractor and/or Contractor's employees or subcontractors. Prior to commencing work under this agreement, and if Contractor utilizes employees or subcontractors to perform work under this agreement, Contractor agrees to provide City a certificate(s) of insurance showing Contractor's and any subcontractor's compliance with workers' compensation statutory requirements.
- (C) Contractor is solely responsible for compliance with all federal, state and local laws regarding reporting of compensation earned and payment of taxes. City will not withhold federal, state or local income taxes or any other payroll taxes.

#### Section 9. Non-Discrimination

Contractor agrees to comply with all federal and Indiana civil rights laws, including, but not limited to Indiana Code 22-9-1-10. Contractor or any subcontractors, or any other person acting on behalf of Contractor or a subcontractor, shall not discriminate against any employee or applicant for employment to be employed in the performance of this agreement, with respect to the employee's hire, tenure, terms, conditions, or privileges of employment or any other matter directly or indirectly related to employment, because of the employee's or applicant's race, religion, color, sex, disability, national origin, or ancestry. Breach of this covenant may be regarded as a material breach of contract.

#### Section 10. Employment Eligibility Verification

- (A) Contractor shall enroll in and verify the work eligibility status of all Contractor's newly hired employees through the E-Verify program as defined in Indiana Code § 22-5-1.7-3. Contractor is not required to participate in the E-Verify program should the program cease to exist. Contractor is not required to participate in the E-Verify program if Contractor is self-employed and does not employ any employees.
- (B) Contractor shall not knowingly employ or contract with an unauthorized alien, and contractor shall not retain an employee or continue to contract with a person that the Contractor subsequently learns is an unauthorized alien.

- (C) Contractor shall require their subcontractors, who perform work under this contract, to certify to the Contractor that the subcontractor does not knowingly employ or contract with an unauthorized alien and that the subcontractor has enrolled and is participating in the E-Verify program. Contractor agrees to maintain this certification throughout the duration of the term of a contract with a subcontractor.
- (D) City may terminate the contract if Contractor fails to cure a breach of this provision no later than thirty (30) days after being notified by City of a breach.

#### Section 11. Contracting with Relatives

Pursuant to Indiana Code § 36-1-21, if the Contractor is a relative of a City of Goshen elected official or a business entity that is wholly or partially owned by a relative of a City of Goshen elected official, the Contractor certifies that Contractor has notified both the City of Goshen elected official and the City of Goshen Legal Department of the relationship prior to entering into this agreement.

#### Section 12. No Investment Activities in Iran

In accordance with Indiana Code § 5-22-16.5, Contractor certifies that Contractor does not engage in investment activities in Iran as defined by Indiana Code § 5-22-16.5-8.

#### Section 13. Indemnification

Contractor shall indemnify and hold harmless the City of Goshen and City's agents, officers, and employees from and against any and all liability, obligations, claims, actions, causes of action, judgments, liens, damages, penalties or injuries arising out of any intentional, reckless or negligent act or omission by Contractor or any of Contractor's agents, officers and employees during the performance of services under this agreement. Such indemnity shall include reasonable attorney's fees and all reasonable litigation costs and other expenses incurred by City only if Contractor is determined liable to the City for any intentional, reckless or negligent act or omission in a judicial proceeding, and shall not be limited by the amount of insurance coverage required under this agreement.

#### Section 14. Force Majeure

- (A) Except for payment of sums due, neither party shall be liable to the other or deemed in default under this contract if and to the extent that such party's performance under this contract is prevented by reason of force majeure. The term "force majeure" means an occurrence that is beyond the control of the party and could not have been avoided by exercising reasonable diligence. Examples of force majeure are natural disasters or decrees of governmental bodies not the fault of the affected party.
- (B) If either party is delayed by force majeure, the party affected shall provide written notice to the other party immediately. The notice shall provide evidence of the force majeure event to the satisfaction of the other party. The party shall do everything possible to resume performance. If the period of non-performance exceeds thirty (30) calendar days, the party whose ability to perform has not been affected may, by giving written notice, terminate the contract and the other party shall have no recourse.

#### Section 15. Default

- (A) If Contractor fails to perform the services or comply with the provisions of this agreement, then Contractor may be considered in default.
- (B) It shall be mutually agreed that if Contractor fails to perform the services or comply with the provisions of this contract, City may issue a written notice of default and provide a period of time that shall not be less than fifteen (15) days in which Contractor shall have the opportunity to cure. If the default is not cured within the time period allowed, the contract may be terminated by the City. In the event of default and failure to satisfactorily remedy the default after receipt of written notice, the City may otherwise secure similar services in any manner deemed proper by the City, and Contractor shall be liable to the City for any excess costs incurred
- (C) Contractor may also be considered in default by the City if any of the following occur:
  - (1) There is a substantive breach by Contractor of any obligation or duty owed under the provisions of this contract.
  - (2) Contractor is adjudged bankrupt or makes an assignment for the benefit of creditors.
  - (3) Contractor becomes insolvent or in an unsound financial condition so as to endanger performance under the contract.
  - (4) Contractor becomes the subject of any proceeding under law relating to bankruptcy, insolvency or reorganization, or relief from creditors and/or debtors.
  - (5) A receiver, trustee, or similar official is appointed for Contractor or any of Contractor's property.
  - (6) Contractor is determined to be in violation of federal, state, or local laws or regulations and that such determination renders Contractor unable to perform the services described under these Specification Documents.
  - (7) The contract or any right, monies or claims are assigned by Contractor without the consent of the City.

#### Section 16. Termination

- (A) The agreement may be terminated in whole or in part, at any time, by mutual written consent of both parties. Contractor shall be paid for all services performed and expenses reasonably incurred prior to notice of termination.
- (B) City may terminate this agreement, in whole or in part, in the event of default by Contractor.
- (C) The rights and remedies of the parties under this section shall not be exclusive and are in addition to any other rights and remedies provided by law or under this agreement.

#### Section 17. Notice

Any notice required or desired to be given under this agreement shall be deemed sufficient if it is made in writing and delivered personally or sent by regular first-class mail to the parties at the following addresses,

or at such other place as either party may designate in writing from time to time. Notice will be considered given three (3) days after the notice is deposited in the US mail or when received at the appropriate address.

#### Section 18. Subcontracting or Assignment

Contractor shall not subcontract or assign any right or interest under the agreement, including the right to payment, without having prior written approval from City. Any attempt by Contractor to subcontract or assign any portion of the agreement shall not be construed to relieve Contractor from any responsibility to fulfill all contractual obligations.

#### Section 19. Amendments

Any modification or amendment to the terms and conditions of the agreement shall not be binding unless made in writing and signed by both parties. Any verbal representations or modifications concerning the agreement shall be of no force and effect.

#### Section 20. Waiver of Rights

No right conferred on either party under this agreement shall be deemed waived and no breach of this agreement excused unless such waiver or excuse shall be in writing and signed by the party claimed to have waived such right.

#### Section 21. Applicable Laws

- (A) Contractor agrees to comply with all applicable federal, state, and local laws, rules, regulations, or ordinances. All contractual provisions legally required to be included are incorporated by reference.
- (B) Contractor agrees to obtain and maintain all required permits, licenses, registrations, and approvals, and shall comply with all health, safety, and environmental rules or regulations in the performance of the services. Failure to do so maybe deemed a material breach of agreement.

#### Section 22. Miscellaneous

(A) Any provision of this agreement or incorporated documents shall be interpreted in such a way that they are consistent with all provisions required by law to be inserted into the agreement. In the

event of a conflict between these documents and applicable laws, rules, regulations or ordinances, the most stringent or legally binding requirement shall govern.

- (B) This agreement shall be construed in accordance with and governed by the laws of the State of Indiana and any suit must be brought in a court of competent jurisdiction in Elkhart County, Indiana.
- (C) In the event legal action is brought to enforce or interpret the terms and conditions of this agreement, the prevailing party of such action shall be entitled to recover all costs of that action, including reasonable attorneys' fees.

#### Section 23. Severability

In the event that any provision of the agreement is found to be invalid or unenforceable, then such provision shall be reformed in accordance with applicable law. The invalidity or unenforceability of any provision of the agreement shall not affect the validity or enforceability of any other provision of the agreement.

#### Section 24. Binding Effect

All provisions, covenants, terms and conditions of this agreement apply to and bind the parties and their legal heirs, representatives, successors and assigns.

#### Section 25. Entire Agreement

This agreement constitutes the entire agreement between the parties and supersedes all other agreements or understandings between City and Contractor.

#### Section 26. Authority to Bind Contractor

The undersigned affirm that all steps have been taken to authorize execution of this agreement, and upon the undersigned's execution, bind their respective organizations to the terms of the agreement.
