Minutes from April 12 and April 19 were presented.

Nichols/Stutsman moved to approve the minutes as presented. Passed 2-0

Mayor Stutsman suggested adding Request for Road Closure and Police Memorial Week.

Nichols/Stutsman moved to approve the agenda as suggested. Passed 2-0

Mechanical License: Patrick K. McKelvey of Emergency Power Sources, LLC

Assistant Building Commissioner Myron Grise presented the request.

Grise stated that as long as the license is renewed, the holder does not need to retake the test.

Nichols/Stutsman moved to approve the Mechanical License for Patrick K. McKelvey for the City of Goshen. Passed 2-0

<u>Downtown Main Street Streetscape Entry Arch Evaluation and Design, JN: 2016-0038</u>

Director of Public Works Dustin Sailor presented the packet memo.

Mayor Stutsman added that Economic Improvement District Board is committing \$10,000.00 to the design.

Nichols/Stutsman moved to award the evaluation and design of the downtown Main Street arches to JPR for a time and materials not to exceed amount of \$30,000.00. Passed 2-0

Agreement for Tree and Stump Removal, JN: 2021-0001

Sailor presented the packet memo.

Sailor stated that this company has been used before. Added the agreement is not ready for Board approval. Also stated that Brad Baron was the bidder.

Nichols/Stutsman moved to have the Mayor sign the agreement with Brad Baron to remove 14 trees and stump grind for the Sidewalk Paving Program for the amount of \$12,500.00. Passed 2-0

Road Closure, 400-block of North 8th Street

Superintendent of Goshen Water Department Kent Holdren presented the packet memo.

Nichols/Stutsman moved to approve the closure of North 8th Street to thru traffic, between Center Street and Summit Street, on Wednesday April 28, 2021 starting at 8:00 a.m. and reopening on Friday evening April 30, 2021. Passed 2-0

The City of Goshen Water and Sewer Department will be replacing a Manhole at 1117 West Ave

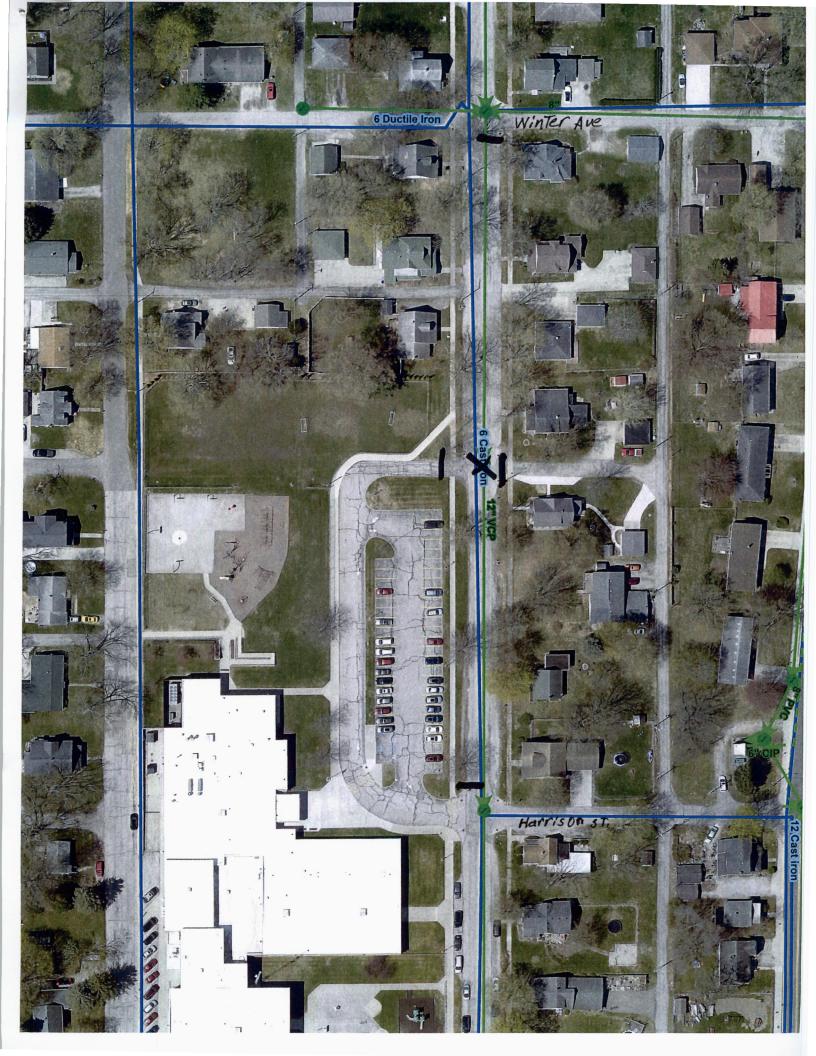

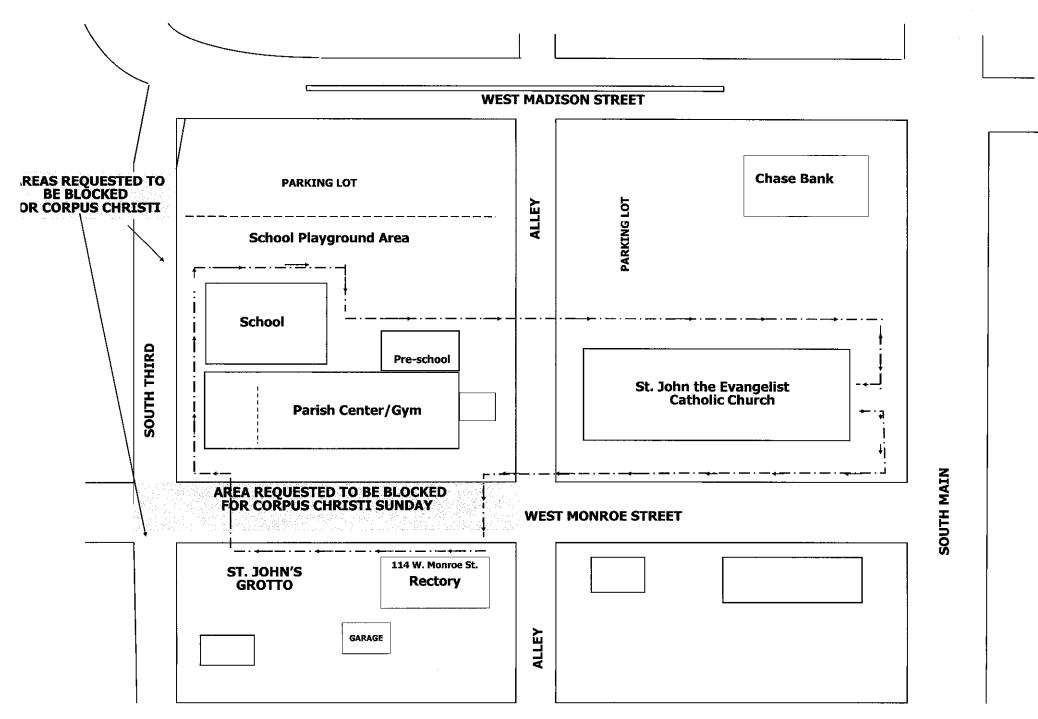

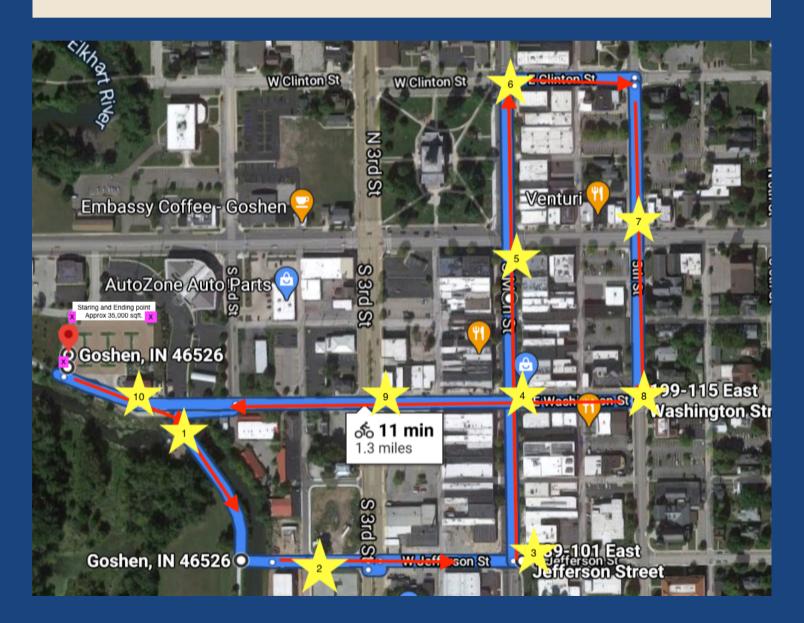

VARIANCE REQUEST TO ALLOW COMPACTED LIMESTONE SURFACE

(City of Goshen JN: 2021-2013)

Dear Board Members:

Affinity RV will be constructing a second building on its property at 2380 East Kercher Road to expand its recreational vehicle service center. The primary building on this property contains the primary water service, sewer service, water meter, office(s), and service bays. The new building will not contain any office space or restroom and will function as a service area supporting the primary structure.

Affinity RV is aware that Ordinance 4333, Section 3.03(M), and Ordinance 4290, Section 1(F) covers the requirements necessary to permit a subordinate sewer connection and water connection to the primary structure's public utility services. We believe our site configuration and building use is consistent with the ordinance requirements, and we request the Board's permission to Building #2 to site's existing sewer and water services.

Affinity RV also respectfully request a variance to the Design Standards and Specifications for Parking and Driveway Surfaces for our Building #2. Back in 2017 with the first building, we received approval from the Board of Works for compacted asphalt millings, but we later found the millings were not holding up. Therefore, we brought in limestone and roller compacted on top of the millings. The compacted limestone has been functioning well for us and we would like permission to install 6" of compacted limestone in front of Building #2.

A representative for Affinity RV will be present at the board meeting to answer questions, as necessary.

Re: Agreement with Ergo Resource Management, Inc.

The City's Wastewater Treatment Plant is in possession of a certain quantity of potassium cyanide, for which it no longer has a need, and it seeks to dispose such in accordance with applicable statutes, regulations, and other laws. The City desires to contract with Ergo Resource Management, Inc. to provide for the disposal of the potassium cyanide in its possession. Ergo Resource Management Inc. agrees provide disposal services as soon as practical and for a fee not to exceed \$800.00.

Suggested Motion: To approve and execute the Agreement with Ergo Resource Management, Inc. for the disposal of potassium cyanide for a fee not to exceed \$800.00

AGREEMENT

For the Disposal of Potassium Cyanide

In consideration of the terms, conditions and mutual covenants contained in this agreement, the parties agree as follows:

Section 1. Contractor Duties

Ergo shall provide City services which shall include the provision of all labor, supplies, materials, tools, equipment, supervision, insurance, and all other items necessary to pick up, transport and properly dispose certain potassium cyanide currently located at the City's wastewater treatment plant in compliance with all applicable statutes, regulations, and other laws (hereinafter referred to as "Duties").

Section 2. Effective Date; Term

- (A) The agreement shall become effective on the day of execution and approval by both parties.
- (B) Ergo shall commence and fully perform the Duties as soon as practical after receiving a notice to proceed from City.

Section 3. Compensation

City agrees to compensate Ergo a sum not to exceed the amount of Eight Hundred Dollars (\$800.00) for performing all Duties.

Section 4. Payment

(A) Payment shall be upon City's receipt of a detailed invoice from Ergo. The invoice shall be sent to the following address, or at such other address as City may designate in writing.

City of Goshen c/o Goshen Wastewater Treatment Plant 1000 W. Wilden Ave. Goshen, IN 46528

- (B) Payment will be made within forty-five (45) days following City's receipt of the invoice. If any dispute arises, the undisputed amount will be paid. Payment is deemed to be made on the date of mailing the check.
- (C) Ergo is required to have a current W-9 form on file with the Goshen Clerk-Treasurer's Office before City will issue payment.

Section 5. Ownership of Documents

All documents, records, applications, plans, drawings, specifications, reports, and other materials, regardless of the medium in which they are fixed, (collectively "Documents") prepared by Ergo or Ergo's employees, agents or subcontractors under this agreement, shall become and remain the property of and may be used by City. Ergo may retain a copy of the Documents for its records.

Section 6. Licensing/Certification Standards

Ergo certifies that it possesses and agrees to maintain any and all licenses, certifications, or accreditations as required to perform the Duties by Ergo pursuant to this agreement.

Section 7. Independent Contractor

- (A) Ergo shall operate as a separate entity and independent contractor of the City of Goshen. Any employees, agents or subcontractors of Ergo shall be under the sole and exclusive direction and control of Ergo and shall not be considered employees, agents or subcontractors of City. City shall not be responsible for injury, including death, to any persons or damages to any property arising out of the acts or omissions of Ergo and/or Ergo's employees, agents or subcontractors.

Section 13. Insurance

Section 14. Force Majeure

The term "force majeure" means an occurrence that is beyond the control of the party and could not have been avoided by exercising reasonable diligence. Examples

- of force majeure are natural disasters or decrees of governmental bodies not the fault of the affected party.
- (B) If either party is delayed by force majeure, the party affected shall provide written notice to the other party immediately. The notice shall provide evidence of the force majeure event to the satisfaction of the other party. The party shall do everything possible to resume performance.  - (3) Ergo becomes insolvent or in an unsound financial condition so as to endanger performance under the contract.
 - (4) Ergo becomes the subject of any proceeding under law relating to bankruptcy, insolvency or reorganization, or relief from creditors and/or debtors.
 - (5) A receiver, trustee, or similar official is appointed for Ergo or any of Ergo's property.
 - (6) Ergo is determined to be in violation of federal, state, or local laws or regulations and that such determination renders Ergo unable to perform the services described under these Specification Documents.
 - (7) The contract or any right, monies or claims are assigned by Ergo without the consent of the City.

Section 16. Termination

- (A) The agreement may be terminated in whole or in part, at any time, by mutual written consent of both parties. Ergo shall be paid for all services performed and expenses reasonably incurred prior to notice of termination.
- (B) City may terminate this agreement, in whole or in part, in the event of default by Ergo.

Any notice required or desired to be given under this agreement shall be deemed sufficient if it is made in writing and delivered personally or sent by regular first-class mail to the parties at the following addresses, or at such other place as either party may designate in writing from time to time. Notice will be considered given three (3) days after the notice is deposited in the US mail or when received at the appropriate address.

THIS CONTRACT is made and entered into on this _____ day of May, 2021, by and between the City of Goshen by its Board of Public Works and Safety, hereinafter referred to as "City," and Eby Ford Sales, Inc., hereinafter referred to as "Supplier."

WITNESSETH, that the City and the Supplier mutually agree as follows:

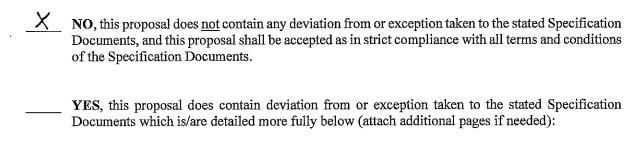

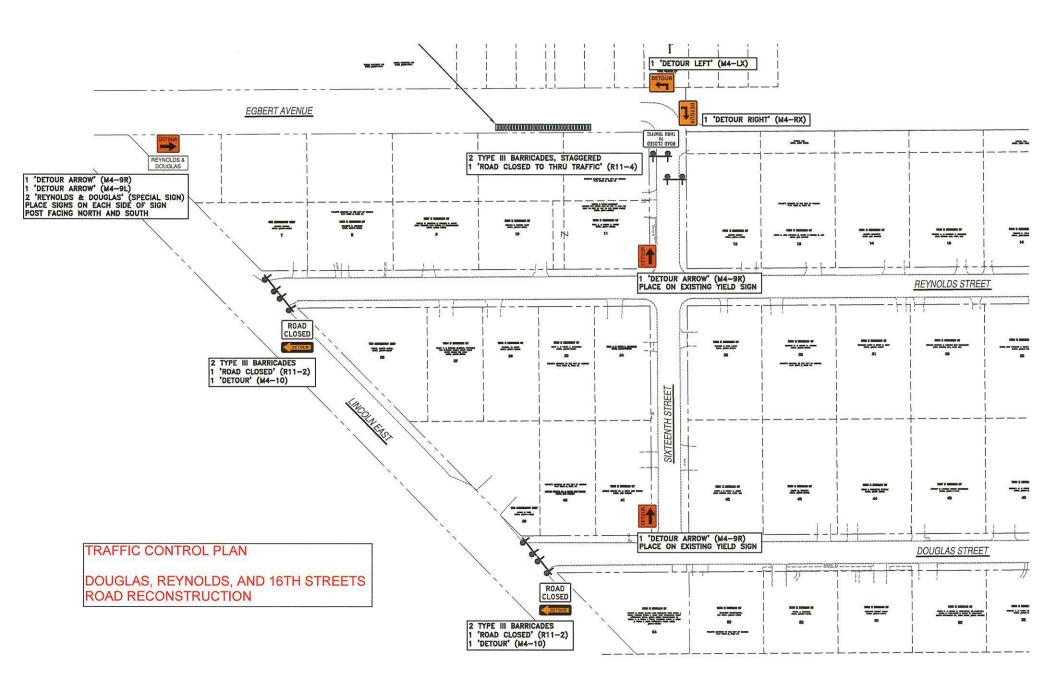
